**International Congress on the Seerah of

Introduction

One notable aspect of the civilization-building conduct of the Ahl al-Bayt (peace be upon them) is the presence of noble, capable, and influential women in their lives. Women who, from positions of honor, exercised a direct influence and played an unparalleled role in shaping and nurturing great, civilization-building individuals, thereby offering to humanity a service as vast as the span of history itself. Eminent women who, in their respective eras, stood in the role of the Imam's mother, contributing to the preservation of the system of Imamate and guardianship (wilayah) and to the advancement of the monotheistic civilization — yet have remained largely unknown to society.

Revisiting their roles holds particular importance for providing role models to the women of our Islamic society. Identifying the abilities and capacities of these women in diverse temporal and spatial contexts can open a new chapter for role-model development and cultural formation concerning the “third model” of the Muslim woman, as well as for fostering civilizational dialogue among nations. Therefore, in order to tap into these capacities, it is essential to compile the body of issues related to the mothers of the Ahl al-Bayt (peace be upon them) and to undertake rigorous scholarly research across multiple dimensions — historical, narrational, theological, educational, and sociological. The findings should then be presented, through various scholarly, artistic, and cultural channels, to governing institutions and to the broader Islamic society.

In line with the realization of this important objective — which is among the emphatic recommendations of the Supreme Leader — the Tadabbor Institute for Qur'an and Seerah Studies, possessing a substantial pool of researchers and nearly two decades of research experience in the field of the Ahl al-Bayt (peace be upon them) and the descendants of the Imams, intends, in cooperation with other scholarly and research institutions, to convene the **International Congress on the Seerah of the Mothers of the Ahl al-Bayt (peace be upon them)** on 26 November 2026.


